COVID 19 TESTING KIT INFORMATION

Dear Participant:

The Departments of Labor, Health and Human Services (HHS), and the Treasury, announced a new policy for COVID 19 testing on January 10, 2022. The policy requires insurance companies and self-insured plans to pay for a limited number of home testing kits per month. Our Health Benefits Fund is covered by that order and policy which is effective Saturday, January 15, 2022.

The COVID 19 home test kits will be covered through our pharmacy, Express Scripts, Inc. (ESI); however, only certain test kits will be covered. As we work through this new program, **please keep any receipts for test kit costs incurred beginning on January 15, 2022**, so that you can be reimbursed by ESI. The Health Fund will be required to pay for up to 8 home testing kits per month per member. The Health Fund and ESI are working on a process for direct payment of test kits through ESI. We will continue to provide you updates on this matter including the process to receive reimbursement through ESI. Below is the list of currently covered FDA approved COVID 19 Home Test kits:
